CONCEPT NOTE

The discipline of Anthropology through its unique holistic methodology has laid emphasis on all-inclusive human attributes starting from heredity to diversity of all kinds that have entered into its methodological domain covering multiple representation of society and culture from early times to the contemporary period. The unique bio-cultural approach is the key to such an approach where each sub-specialization of Anthropology plays its part in contributing to the total aspects of origin of man and its diversity, looking at it from the standpoint of biocultural development over time and space.

Biological Anthropology, with the main focus on biocultural development, has, however, been subjected to various environmental challenges over time and space. Human evolution and variation are the two key subject areas of Biological Anthropology which provide the basis of human biological identity. It is widely recognized that human evolution has been driven by two systems of heredity: one DNA- based and the other based on the transmission of behaviourallyacquired characters. The root cause of human diversity is variation as it contributes to the process of evolution and forms the basis of heredity. Variation is caused due to gene mutations, the interaction of genes with environment and various combinations of genetic materials producing differential effects.

Development and welfare are the two most covetable objectives of India to bring about all round well-being of its population. Incidentally, the United Nations Development Programme defines Human Development as "the process of enlarging peoples choices". The ability to exercise such choices would allow them to "lead a long and healthy life, to be educated, to enjoy a decent standard of living" as well as ensure "political freedom, other guaranteed human rights and various ingredients of self- respect." The Preamble and the Directive Principles of our State Policy have the moot objective to make India achieve the status of a welfare state. Article 38 of our Constitution reads, "The state shall strive to promote the welfare of the people by securing and protecting as effectively as it may, a social order in which justice - social, economic and political shall pervade all institutions of national life." In a diverse country like India, where cultural specificity marks the social existence of different groups of people, this can hardly be achieved bypassing culture or reducing it to an inconsequential non-entity.

Anthropology in the form of Bio-Cultural Anthropology has much to offer in the field of culture and the way it becomes conditioned by biology and environment. While doing so, it appears as a perfect blend of Biology and Culture within the premise of environment where attributes of heredity and diversity flourish on the one side and culturally-specific development and welfare occupy the other. Anthropologists and other biological and social scientists have been focusing on multiple dimensions of both biological and cultural studies from time- space perspective at the global level in general and India in particular. The Conference provides the opportunity for all of them to come together and exchange ideas. Focal themes, as listed below, will be able to identify the relevant concern areas of Anthropology in the context of today's India.
