





OFFICE ORDER

As per the advice of the Disciplinary Committee, the undersigned issued an order on 17.12.2022 prohibiting Sri Saurav Ghosh of Political Science, Sem-III from taking normal entry to the college without prior approval of the Principal. Also he was declared to be debarred from appearing the Internal Examination going to be started on and from 03.01.2023, vide memo no. 678/22 dated 17.12.2022.

All these actions were taken as disciplinary steps against Sri Saurav Ghosh as he did not comply with the order of the Principal and did not appear along with his guardian on 16.12.2022.

Sri Saurav Ghosh, however, wrote to the Principal on 19.12.2022 that he could not appear along with his guardian on 16.12.2022 because of illness of his guardian. But he could manage to get time to write this only after the disciplinary order under memo number 678/22 dated 17.12.2022 was issued against him. Not only that he did not bother to substantiate his guardian's illness with any medical certificate and requested the Principal to arrange a different date for appearing.

Whereas, Sri Saurav Ghosh could have given intimation of non-appearance on 16.12.2022 beforehand;

and

Whereas, Sri Saurav Ghosh did not mention in his submission, the reason for not informing the Principal beforehand about the cause of his non-appearance:

- The order for not allowing entry to the college as imposed on him, vide memo number 678/22 dated 17.12.2022, stands.
- But as he wrote to the Principal for exemption after the order under memo number 678/22 dated 17.12.2022 was served upon him, he is hereby allowed to take entry only on the days of Internal Examination starting from 03/01/2023.
- Further decision on this issue will be delivered only after the meeting of the Disciplinary Committee with the guardian of Sri Saurav Ghosh, the date of which will be notified when the college reopens after the winter vacation.

A copy of this order is being forwarded to the security person on duty to the entry gate to enable him to enforce the order of the Principal.
